Item 1: Acquisition of 672(+/-) Acres in Douglas County, Region 2
Central Ferry Canyon Unit, Wells Wildlife Area

Background summary:

This proposal is phase 2 of the Central Ferry Canyon property to acquire an additional 672(+/-) acres adding to the 1,513-acre phase purchased in April of 2022 from the same owner. The total property acquired will be 2,180 acres of wildlife habitat in Douglas County and will protect and conserve shrubsteppe obligate species. This project will be added to the Wells Wildlife Area, Central Ferry Canyon Unit and consists of extensive shrubsteppe habitat for mule deer, Columbian sharp tailed grouse, greater sage-grouse, and habitat for the conservation of Columbia Basin pygmy rabbit.

Approved through Lands 20/20 in 2018, the appraised value of this acquisition is \$551,000, which will be provided through a Cooperative Endangered Species grant from the US Fish and Wildlife Service.

Ongoing operation and maintenance costs for this proposed 672(+/-)-acre acquisition property is expected to be \$125 per acre and will be included in WDFW's 9v decision package for ongoing operation and maintenance for newly acquired land.

Per <u>RCW 77.12.201</u>, Douglas County does currently opt into PILT (Payment in Lieu of Taxes) as provided for in <u>RCW 77.12.203</u>. This property is expected to add an additional \$470 annually to Douglas County's PILT payment.

Staff Recommendation:

Staff recommend Commission approval to acquire 672(+/-) acres at the Wells WLA, Central Ferry Canyon Unit, pursuant to RCW 77.12.037.

Policy issue(s) and expected outcome:

Protecting critical habitat and providing recreational opportunities.

Fiscal impacts of agency implementation:

Operation and maintenance costs.


